Candidate will have to email the application in prescribed format only, scanned self-attested photocopies of all the required certificates/marksheet from secondary onwards, tabulated information of publications and experience certificates, if any. All original or provisional degree/mark sheets from Secondary examination onwards, Date of Birth proof, UG/PG certificates/Grade cards/mark sheets, credentials, working experience, if any, will have to be produced by the successful candidate at the time of joining for verification, failing which, the offer of appointment will be deemed cancelled.

- 5. Last date for submission of application is on or before 17<sup>th</sup> Nov, 2021 and interview will be held at 11:00 AM at PPV&FR Authority, New Delhi.
- 6. The posts are purely temporary and will be filled on contractual basis initially for one year which may be extended periodically subjected to performance or till the termination of the project.
