Terms and conditions:

- 1. **Age limit:** Not more than 35 years for PVERA, SRF, YP, Law Research Associate and Legal Associate as on the last date of application submission. Age relaxation of **five years** for SC/ST/woman candidates and **three years** for OBC can be considered. In case of deserving qualified candidates already working in the establishment or in similar temporary service in central government in the subject area, the age limit shall not apply, but shall not be above 65 years of continuous service.

- 4. The candidate intending to attend for interview, if any of his near or distant relative is an employee of the PPV&FR Authority, have to declare his/her name, designation, nature of duties, relationship in advance in writing during submission of the application form
- 5. Candidate will have to email the application in prescribed format only, scanned self-attested photocopies of all the required certificates/marksheet from secondary onwards, tabulated information of publications and experience certificates, if any. All original or provisional

degree/mark sheets from Secondary examination onwards, Date of Birth proof, UG/PG certificates/Grade cards/mark sheets, credentials, working experience, if any, will have to be produced by the successful candidate at the time of joining for verification, failing which, the offer of appointment will be deemed cancelled.

- 6. Last date for submission of application is 24th June, 2022 through respective PIs mail id and the interview for the post of Plant Variety Examination Research Associate, Legal Research Associates and Legal Associate will be held on 30th June, 2022 from 11 am and the interview for the post of SRF and Young Professional will be held on 01st July, 2022 from 11 am onwards.
- 7. The posts are purely on temporary basis and will be filled on contractual basis initially for one year which may be extended periodically subject to performance or till the termination of the project.
- 8. Candidate shall not claim regular appointment at this institute, as the post is co-terminus with the project.
- 9. No TA/DA will be paid for joining.
- 10. Only the candidate having essential qualification would be allowed for the interview and the decision of PPVFRA shall be deemed final in this regard.
