
Sub: -Extension of time limit for compliance to directions of Registrar after allotment of REG number- Extension of time limit for various statutory proceedings provided under PPV&FR Act, 2001 time limit is not extended for submission of Seeds/Planting materials, submission of Registration/DUS Test Fee, Submission of Annual Fee/Renewal Fee/Filing of Annual Return Form, submission of application for registration of extant varieties whose time limit has expired by 3rd January, 2022 by virtue of Public Notice 16 of 2021/New varieties whose novelty period ends by 03.10.2022 by virtue of Public Notice 17 of 2021.

In accordance with the order dated 10th January, 2022 of Hon'ble Supreme Court in *Suo Motu Writ Petition (C) No.3 of 2020* and in continuation of Public Notice 16 and 17 of 2021.

1. The time limit is extended till 29.05.2022 for the following matters:-
 - a) Time limit various statutory proceedings provided under PPV&FR Act, 2001 and PPV&FR Rules, 2003.
 - b) Time limit for compliance to directions of Registrar after allotment of REG number.
2. The time limit is not extended for the following matters:-
 - a) Submission of Seeds/Planting materials.
 - b) Submission of Registration/DUS Test Fee.
 - c) Submission of Annual Fee/Renewal Fee/Filing of Annual Return Form.
 - d) submission of application for registration of extant varieties whose time limit has expired by 3rd January, 2022 by virtue of Public Notice 16 of 2021
 - e) New varieties whose novelty period ends by 03.10.2022 by virtue of Public Notice 17 of 2021.
